

**NOTIFICATION**

The Royal Civil Service Commission during its 37th Commission Meeting held on March 17, 2020 noted that the agencies are facing disruption in its service due to relieving its employees on lateral transfer to vacant positions created by civil servants availing Extraordinary Leave. Therefore, in order to avoid disruption in the service delivery, the Commission decided that such vacancies created by civil servants availing Extraordinary Leave shall not be filled up through the modality of recruitment through lateral transfers.

This notification shall supersede the earlier notification circulated vide letter No. RCSC/LS-57/2018/5468 dated May 25, 2018 and shall be effective from March 18, 2020 with the exception of announcements that have been made prior to this notification.
