Her application dated 19/03/2020 states saying that she wants to be ESP under Dzongkhag instead of Gewog in order to eligible for allowances as Dzongkhag ESPs do. Since she is recruited by Gewog she is not considered as civil servant and is not covered for any allowances. BCSR has no provision mentioning on entitlements of Gewog recruited employees.	Deferred to next HRC
5	Mr. Tandin Wangchuk CID 11910000930 Geydrung of Nisho Gewog appeals to Dzongkhag to review the procedure followed by Gewog Administration to terminate him from the service.	His application dated 24/3/2020 states 3 points as under: 1. Gewog Administration did not serve him any single reprimand for his non-performance prior to putting this case to Dzongkhag Human Resource Committee and wants to know who has put to DHRC. 2. He wants to know who has been assigned to perform his job if he had failed, if he had failed, does Gewog Adm. reminded and advised him for improvement? 3. He wants to know if Gewog Adm. has followed due process as per Local Government Rules for his termination?	Dzongkhag is of opinion that all due processes have been followed in termination of Geydrung by Gewog. Therefore, Dzongkhag respects the decision of GT.

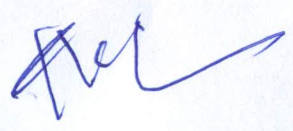
