3. Do not upload any new tenders on e-Tool till 31st of August 2019.
4. Procuring agencies are advised to make necessary changes in their Annual Procurement Plan in e-Tool and e-GP accordingly.

The Secretariat will not be liable for any discrepancies that would arise due to non compliance to the above.
